### **Bill Johnson, Tax Assessor:**

Two RFPs were received for the reval; one from Professional Property Appraisals at \$57,160 and the second from Vital Computer Resources at \$84,900. Mr. Johnson recommends Professional Property Appraisals not only based on the proposal but also because they offer a better product and public relations. Additionally, one inspector will complete the entire town. Once a contract is in place it will need to be approved by the NJ Division of Taxation and should start early spring...March. Prior to the inspection a letter will be sent to the residents. Appointments cannot be made until the letter goes out or the inspector comes to the home. Residents will have the opportunity to informally confer with the assessor regarding the assessments.

# **Gerry Creighton, JORBA:**
