#### **MAYOR'S APPOINTMENTS:**

#### **COUNCIL PRESIDENT'S COMMITTEE ASSIGNMENTS:**

Council President Rummler stated that the Public Works Committee will consist of himself, Councilman Roger Giberson and, Councilman Kevin Wessler, who will replace outgoing Councilman Bob Haviland. Council President Rummler appointed Councilmember John Adams to the Recreation Committee. Councilwoman Riegel had a recommendation to appoint Councilman John Adams to Chair the Finance committee along with Bugdon and Riegel. All other committees will remain the same.

#### **State of the City Address**

Council President Rummler commended that last year was a busy year with all the meetings that were held. Some good things came out of the year. The City secured some land, and by securing more land, the City was able to take the land out of the hands of developers. The City acquired the mining permit. The down side was the loss of City Hall. We also had many changes in City Hall with personnel. Everything is working out for the better. Council President Rummler hopes to have the next reorganization meeting in the new city hall next year. The City may close on more land for the historical society. Councilwoman Bugdon stated she would also like to see it for a place for the Boy Scouts to have.

Council President Rummler would like to point out some outstanding councilmember's: Number one Roger Giberson for all his hard work along with his Public Works Committee, Councilmember Kevin Wessler and Councilmember Bob Haviland. Everyone on Council worked hard this year.

We had a significant change in employees. Jim Milton Public Works Supervisor is doing a wonderful job along with Dan Giberson. Another acknowledgment should go to Acting City Clerk, Kimberly Campellone and Deputy City Clerk/Acting CFO, Gina Simon, for a job well done; turning the office around with the finances and organization. He is anticipating a very good year. The City also had a change in the court personnel. We have a new Court Administrator who is a local resident, who has also trimmed the expenses. Council President Rummler cannot thank them enough.

Mayor Giberson praised City Council, Planning Board and Employees. Mayor Giberson is pleased that the Governor has an open door policy to all Mayors. Mayor Giberson explained that this year 2011, was one of the worst winters ever; the City of Port Republic had beach erosion, trees down, and bulkhead problems. He is working with the state on the Mill Dam; the wing wall has pulled away from 3/8" to 1/4". He is grateful for all the volunteers and residents; everyone should be very proud of Port Republic. Councilwoman Reigel commented that she is anticipating the new city hall come under budget and that the City will be able to purchase the property for Councilwoman Doris Bugdon artifacts. Councilwoman Bugdon is looking forward to a zero increase in taxes and the house for historic use. She enjoys her position on city council and working with everyone.
