Police/Emergency Management:

Administrative/Personnel:

Mayor Giberson reported that Council received monthly reports from the Municipal Clerk, Tax Collector, and Chief Financial Officer.

The Municipal Clerk's report for June 2024 showed a total amount received of \$12,760.72.

Recreation:

Councilmember Turner stated how nice Port Day was this year and that there was a great turnout. The fireworks were beautiful and there were no fires or incidents otherwise. The park area looked amazing, and he received many compliments on how great the area looked.

Fire and Ambulance:

Councilmember Hawn reported that there were no fires during the month of June. They had a fire on July 4^{th} , but that was handled without incident.

Planning Board:

Councilmember Riegel reported that the Planning Board met on Monday, July 8th. They heard from a representative of Blueberry Hill Campground and their counsel. They came before the board to obtain clarification of accessory uses for a campground. The applicant along with their counsel demonstrated that there has been a history of resident caretakers on the property. The Planning Board found that, in this

instance, a caretaker's cottage is an accessory use. Therefore, the applicant does not have to go through zoning.

Construction/Code Enforcement:

Construction Official Richard Stevens submitted a report for the month of June. During the month, a total of 14 inspections were done, and the following permits were issued:

OPEN TO PUBLIC PORTION:

On the motion of Councilmember Turner, seconded of Councilmember Riegel and carried to open public portion.

Mayor Vince Sera of Brigantine made a presentation to Mayor and Council informing them of the upcoming offshore wind projects. He urged Council to adopt resolution 74-2024 which unequivocally opposes offshore wind projects, encouraging all municipalities to join opposition and supporting the Atlantic County Executive and Board of Commissioners to utilize its various powers, including legal action to protect the future of Atlantic County. Mayor and Council thanked him for his presentation.

Becca Wessler, 601 Chestnut Neck Road, added that Brigantine along with all the municipalities of Long Beach Island are putting out thousands of taxpayer dollars to fight this. It is a big issue.

Chris Stankus, 321 Clarks Landing Road, shared with Mayor and Council that he has been dealing with water coming from Blueberry Hill Campground's drainage onto his property. It was addressed previously, but their solution is not working. In addition, Mr. Stankus has been trying to contact the County regarding the culvert in front of 329 Clarks Landing Road. Only about a quarter of it is working. Mayor Giberson asked Mr. Stankus to email her the videos and pictures he has, and she will contact the County on his behalf. Attorney Kaufmann explained that if there is a site plan on file with the City, it should include a drainage plan. The City's Code Enforcement Officer/Zoning Official can review that plan to see if what is going on comports with the approved site plan. If there is no site plan on file, being that the campground is so old, his advice to Mr. Stankus is to confer with an attorney as this issue is what is referred to as a private nuisance. Councilmember Bugdon also suggested that the issue be brought to

the County Heath Department's attention. Councilmember Riegel suggested that The Pinelands also be made aware of the issue.

Attorney Kaufmann asked Council if they would like to do generic request for proposals which would allow for any and all projects and possibly open the doors to ideas that Mayor and Council may not have thought of before. Council would like to put out a request for proposals for the lease of the land to refill the pit with dredge spoils. Once the pit is filled, they would like to put out a request for proposal to get ideas for the land. Councilmember Turner asked if the request for proposals can be discussed in executive session. Attorney Kaufmann said that it can be while the details are being worked on. Ultimately when they approve the request for proposal it must be done in open session by resolution. Councilmember Turner would like a special meeting to get this approved sooner. Clerk Blevin will discuss with Council President Giberson.

NEW BUSINESS:

• Interlocal Agreement Between Atlantic County Utilities Authority (ACUA) & City of Port Republic to Provide Roll-Off Container Service (agreement to expire October 1, 2024)

Council would like to stay with the ACUA and renew the interlocal agreement.

MAYORS REPORT/PROCLAMTIONS:

Mayor Giberson reported:

- Port Day went really well. There was a celebration to honor the fire fighters and it was a special honor for her to know that 18 of the members are lifetime members and 2 members have been with the department for 69 years.
- Plans for the Duct Tape Boat Regatta have begun. It will be held on Sunday, September 15th. They are hoping to add a fundraiser for the Education Foundation.
- Bill Smallwood will be utilizing funds from the Port Republic Athletic Foundation to hire a landscaper to clear out the Longo/Smallwood Garden area.
- The city-wide yard sale went well this year. It was run by Gretchen Halfpenny and she will be running it again next year.
- Repaying of Mill Road is supposed to begin this week.

Joe Martin, 5 Mill Street, questioned when the paving of Mill Road from Main Street to Riverside Drive would be taking place. This portion is being done by the County. Ultimately, it will be when the asphalt company schedules the jobs.

Mayor and Council discussed the progress of the bridge. The County is still waiting for approval from the DEP to finish the drainage job.

Stephanie Grossman, 135 Old New York Road, discussed an incident where her partner's picture was posted to a Facebook group. He was on their property in the wooded area and his picture was being circulated because one of the neighbors thought he was a strange person. They are unable to join the Facebook group and wanted to introduce themselves as this could have turned into a bad situation.

Mayor Giberson reminded residents that if there is an issue they should contact the State Police immediately.
