

COMPACTOR USE:

Household trash/garbage only.
Please note: household non rechargeable batteries are not recyclable and shouldn't be discarded in the Compactor. PLEASE NO recyclables, construction debris, metal objects, wood, or yard waste in the Compactor.

OPEN TOP CONTAINER USE:

Bulky items only. Ex: furniture, non-recyclable items, wood, etc. **NO metal objects, tires, garbage, or leaves.** Only one pick-up sized truck load per household per week.

METAL OPEN TOP CONTAINER USE:

Ex: refrigerators, washers, dryers, stoves, grills, lawnmowers, pots, pans, air conditioners, swing sets, car rims, etc. **NO tires.**

COMMERCIAL WASTE IS PROHIBITED

ALL TRASH CONTAINERS MUST HAVE A SECURED LID

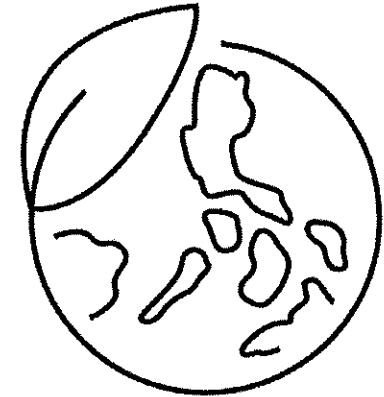
The following items are
NOT permitted:

antifreeze, paints, branches larger than 4" in diameter, pesticides, compact fluorescent bulbs (CFL's), propane tanks/bottles, concrete, thinners, freon, tires, herbicides, toxic chemicals, medical needles, tree stumps

YARD WASTE: bushes, shrubs, and briars. **NO stumps, logs, or branches larger than 4" in diameter.**

WASTE OIL & VEHICLE

BATTERIES: Use funnel to pour into oil tank. Please keep your container to use again. Place vehicle/boat batteries near oil tank.

CLOTHING/FABRIC: Place in the AmVets container.

LEAVES/GRASS CLIPPINGS: Use the compost site.

RECYCABLES:

PLASTICS: #1,2 & 5 plastic bottles, containers, and jugs. Ex: water bottles, milk jugs, shampoo bottles, laundry detergent jugs, condiment containers, plastic egg cartons, yogurt containers, iced coffee cups, margarine tubs. **NO food/liquid residue or plastic bags.**

METALS: aluminum, tin, or steel cans

GLASS: All glass bottles/containers/jars - lids and caps removed and thrown away (if metal, recycle separately)

HOUSEHOLD HAZARDOUS

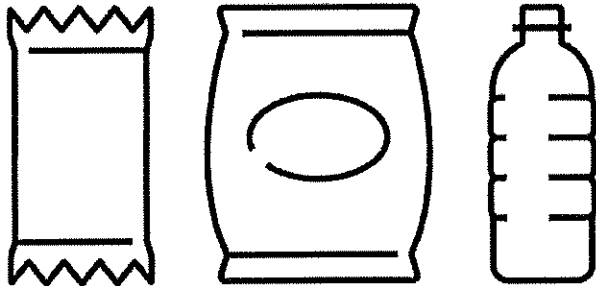
WASTE: The Atlantic County Utilities Authority (ACUA) holds collections during the year. Call ACUA at 609-272-6950 for information or visit www.acua.com

For more information regarding material not accepted here, please call the City Clerk's Office at 609-652-1501. If everyone does their part to recycle properly, the City will pay less for disposal & earn more money through an annual grant.

ELECTRONICS:

Accepted items: ac adapters, lead acid batteries, aluminum, brass, light iron, copper, metal (baled/loose), audio/video equipment, motherboards, b, c, tweeners/finger boards, ballasts(**NON-PCB's**), motors, car batteries, mp3 players/iPod, cash registers, pc fans/power supplies, cell phones/telephones, pc scrap/stereos, computer memory, pcs (desktop, laptops, tables, towers), computer periphery/parts, police scanners/pagers, e-readers, portable radios, game consoles, printers, copiers, scanners, gold clip ends, modems, fax machines, handheld/table mounted scanners, scales, hard drives, televisions, household appliances (not containing a compressor), toner/ink cartridges, keyboards, mice, pc speakers, uninterrupted power supply, laptop/cell phone batteries, vcr/dvd/blueray/laser disk/cd players, lcd/crt computer monitors, wire (all types), yokes.
