School Board Member Kevin Wessler spoke to Mayor and Council regarding the various increases the school is facing. Increases include health insurance costs and tuition due to Greater Egg Harbor. There have been meetings to discuss the formula that determines the tuition the school board needs to pay to Greater Egg Harbor. It is a work in progress.

Councilmember Riegel questioned the increase which was received in State funding. Mr. Wessler explained that it was an increase received for choice students. Councilmember Riegel explained that the printout she had was showing an increase in total fees received.

There was discussion on the reason why Port Republic is paying tuition as a sending district to the high school rather than becoming part of the Greater Egg Harbor Regional.

MAYORS REPORT/PROCLAMTIONS:

Mayor Giberson reported:

- She attended a meeting at the Atlantic County Board of Taxation. They are trying to figure out the most advantageous way to reassess and reevaluate each municipality. This will cost the City approximately \$68,000.00.
- She attended a meeting regarding the Atlantic County Central Municipal Court. Northfield has pulled out and have joined with Hammonton. There will be no increase in the 2025 budget for Port Republic.
- She also attended a meeting regarding Affordable Housing. The NJDCA updated their numbers, and we are now mandated to have 10 units. The Planning Board will be discussing this and can make recommendations on where these units should be.
- During the Recreation Committee Meeting, the coaches had some suggestions on how we could obtain grants for lighting of the field and possibly a scoreboard.

Jill Yochim, Port Republic School Board Member, clarified that for the 2025-2026 school year Port Republic School received an increase in State Aid of \$12,913. She expressed that when you look at the growth in the budget, this number is not significant.

Someone in the audience questioned what the tax increase will be. Councilmember Riegel responded it will be 1.3 cents for the City portion. He asked if there was an idea yet of what the school increase would be. Mayor Giberson responded that right now, they are estimating a 7.7 cent increase. This does not include a bond to repair the school building. The audience member questioned who would pay for the bond. Mayor Giberson responded that the taxpayers would be responsible to pay for that.

A lengthy discussion ensued regarding the Port Republic School's budget.
