Grilled Chicken Salad with Avocado and Raspberries

from the mayor's kitchen

INGREDIENTS:

- 5 TBS Dijon mustard
- 2 TBS Brown Sugar
- 1 1/4 tsp salt
- 4 Chicken breasts
- 3 TBS olive oil
- 2 TBS apple cider vinegar

- 10 cups favorite salad greens
- I cup raspberries, halved
- I avocado, halved, pitted, and cut into ½ inch pieces
- ½ cup chopped pecans, toasted

STEPS:

- I. Combine mustard, sugar and salt in a large bowl. Transfer 3 TBS mustard mixture to second large bowl and set aside. Pat chicken dry with paper towels. Add chicken to remaining mustard mixture (first bowl) and toss to coat
- 2. Grill chicken over hot fire until well browned and registers 160 degrees, about 6 minutes per side. Transfer chicken to cutting board and tent with foil.
- 3. Whisk oil and vinegar into reserved mustard mixture. Add salad greens and toss to combine. Slice chicken ¾" thick. Top salad with raspberries, avocado, pecans, and chicken. Season with salt and pepper to taste and serve.

Atlantic County NJ Property Alert Service

This service is the first step in protecting your property. Unfortunately, property and mortgage fraud is a fast growing crime in our country. In some cases, fraud on real property is not discovered for years. To address these concerns, and protect one of your most important assets, our office offers this FREE service to notify you immediately via email whenever a document with your name is recorded in the County Clerk's Office.

Please sign up today and protect your property from fraud. It's quick, easy and free. Simply follow the steps below and you will automatically be notified electronically when a document is recorded with your name.

- 1. **Getting Started:** Please register your username and password to begin the registration process.
- 2. **Confirmation Email:** After you receive your confirmation email, please click the link provided in the email to return to the parameter for your alert.
- 3. **Register Party Name:** Register a party name and receive alerts when documents are recorded with a matching name. All variations of the name should be registered. For example, John Smith, Smith John A, and Smith John Allen respectively. Entity names may also be registered for an alert. For example, ABC Rentals LLC. Be aware that party names are the predominant index field in County Clerk data.

Please see the county <u>Official Records Public Search</u> page to verify matching party names from previously recorded documents. Click where indicated to launch the search application, then search on party name.

4. **Register Property Information:** Altermatively, subscribers may submit parcel data - **municipality, tax block and lot** for an alert. Be aware that parcel data is not contained in all documents recorded and therefore not captured in the database. The registration of party name(s) is recommended for email alerts. The registration of parcel data is secondary.



New Jersey Property Tax Relief

For Senior Homeowners and Renters Age 65 and Over

- Three Programs, One Combined Application
- Based on 2024 Residency, Income, and Age
 - File by October 31, 2025

Eligibility requirements, including income limits, and benefits available for all property tax relief programs are subject to change by the State Budget.

NJ residents born before 1959 or permanently disabled residents receiving Social Security disability payments as of 12/31/23 may be eligible if you:

- Owned and lived in your home (or leased a site in a mobile home park and lived in your mobile home) in 2020 and through December 31, 2024;
- Paid property taxes by June 1 (site fees by Dec 31); and
- Meet the 2023 and 2024 income limits.



Affordable NJ Communities for Homeowners & Renters

Property Tax Relief For:

- Homeowners Earning \$250K or Less
- Renters Earning \$150K or Less

Stay NJ

For Senior Homeowners

- ♠ Age 65 or over in 2024
- **★** 2024 income below \$500,000

Stay NJ benefits are calculated after ANCHOR and Senior Freeze benefits are determined. If you qualify for all three programs, the Stay NJ benefit will be 50% of your property taxes (up to \$13,000) minus any payments received through ANCHOR and Senior Freeze (2024 benefit cap of \$6,500).



2024 NEW JERSEY PROPERTY TAX RELIEF FAQ

What has changed about New Jersey's Property Tax Relief programs?

For the first time, NJ residents can apply for three PTR programs – Senior Freeze, ANCHOR and Stay NJ – on a single application called PAS-1. This combined application can be used by both homeowners and renters. There will no longer be ANCHOR-H or ANCHOR-T applications.

Who can file the combined property tax relief application Form PAS-1?

New Jersey residents who were 65 and older, or recipients of Social Security Disability, during Tax Year 2024 may be eligible to file the combined application (Form PAS-1).

How is the combined application different from previous applications?

- For Senior Freeze recipients, the application looks different, and the income standards also have changed. You no longer have to include proof of property taxes paid. If you already have a "base year" established, it will be printed on line 13 for homeowners, or line 21 for mobile homeowners.
- For ANCHOR homeowner recipients, you are no longer required to have an Identification Number and PIN to file for benefits.

When is the filing deadline?

The deadline for submitting a Tax Year 2024 property tax relief application is October 31, 2025.

How does the applicant file?

If the applicant was 65 or older – or a recipient of Social Security Disability – in Tax Year 2024, they will have two ways to file:

- File a paper property tax relief application (Form PAS-1) for all three property tax programs: ANCHOR, Property Tax Reimbursement (Senior Freeze), and the Stay NJ Property Tax Benefit.
- Alternatively, they have the option to file the combined application online at propertytaxrelief.nj.gov
- There will be no auto-file for these applicants.

What if the applicant was under 65 or did not receive Social Security Disability in Tax Year 2024?

They will file their property tax relief application via one of the following methods:

- The Division will auto-file for some applicants;
- They can file an online application at propertytaxrelief.nj.gov; or
- They can file a paper application.

The online application will be the same for all applicants regardless of age, disability status, or whether they own or rent their principal residence.



2024 NEW JERSEY PROPERTY TAX RELIEF FAQ

Will information be sent to applicants regarding the Senior Freeze, ANCHOR and Stay NJ benefit amounts?

The Division will send a letter to combined application filers explaining the ANCHOR, Senior Freeze, and Stay NJ benefit amounts calculated for each applicant.

The Division will begin sending these letters in October 2025.

Will property tax relief applications be mailed to eligible individuals?

Individuals who are 65 and older or recipients of Social Security Disability are expected to begin receiving the combined application (Form PAS-1) by mail in March 2025. Individuals who are under 65 or do not receive Social Security Disability are expected to begin receiving applications by mail in late summer 2025.

Will applicants still need to provide proof of property taxes due and paid?

No. There is no need to provide proof of property taxes paid (no Senior Freeze verification forms: PTR-1A, PTR-1A Co-op, PTR-1B, PTR-2A, PTR-2A Co-op, or PTR-2B), even for first-time applicants.

How will applicants receive property tax relief payments?

Applicants who file a paper PAS-1 application will be mailed a paper check. There will be no direct deposit payment option for these applicants.

Applicants who file the online PAS-1 application at *propertytaxrelief.nj.gov* will have the option to receive a direct deposit.

When will property tax relief payments begin?

- Property Tax Reimbursement (Senior Freeze) payments will begin on July 15, 2025.
- ANCHOR payments will begin in September 2025 and continue on a rolling basis. Most
 applicants will receive their payment about 90 days after applying, unless additional
 information is needed to process the application.
- Stay NJ program benefit payments are expected to be paid quarterly beginning in 2026. The payments will be scheduled for February 2026, May 2026, August 2026, and November 2026. The February 2026 and May 2026 payments are subject to budget appropriations in the Fiscal Year 2026 State Budget. The August 2026 and November 2026 payments are subject to budget appropriations in the Fiscal Year 2027 State Budget.

^{*} The availability of New Jersey's property tax relief programs is subject to State Budget appropriations.

LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS

I, the undersigned, in consideration for my participation in the Port Day Parade (hereinafter, "Parade"), do hereby release and discharge the City of Port Republic, New Jersey and any and all of their respective elected officials, officers, directors, employees, volunteers, partners, contractors, and/or any other associates in whatever form or fashion (hereinafter, the previously listed categories may be collectively referred to as "Parties" if not fully listed), jointly and severally, from any and all liability for personal injury accident, illness, death, property damage or any other occurrence, foreseeable or unforeseeable, which I may suffer in any manner whatsoever arising out of or resulting from participation in said Parade.

To the best of my knowledge, I can fully participate in this Parade without any physical or other hindrance. I am fully aware that there are potential risks and hazards, foreseeable and unforeseeable, connected with the Parade, and I hereby elect to voluntarily participate in said Parade, and to enter the above-named premises and engage in such Parade knowing that the Parade may be hazardous to me and my property.

I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such a Parade, WHETHER CAUSED BY THE NEGLIGENCE OF THE PARTIES or otherwise.

Furthermore, I expressly assume ALL risks of my participation in the Parade, including, without limitation, injury as a result of the acts or omissions of any of the above-named Parties, or some defect in or on the above named Parties' property or on the parade route, including, but not limited to, the defined route and/or any and all approach routes, whether caused by negligence or otherwise, except for illness and injury resulting directly from the gross negligence or intentional misconduct on the part of the Parties.

It is my express intent that this LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns and personal representative, if I am not alive, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE THE ABOVE-NAMED PARTIES.

I hereby further agree that this LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS shall be construed in accordance with the laws of the State of New Jersey.

I certify that any and all individual(s) that are participating in conjunction with my participation in the Parade have read and voluntarily and freely executed a separate copy or copies of the LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS and that copy or those copies have been appropriately and timely filed with the City of Port Republic prior to the Port Day Parade.

By making this certification, I aver and covenant with the City of Port Republic that I will not permit, allow, or otherwise acquiesce to the participation of any individual, individuals, entity, or entities that have not appropriately and timely filed with THE CITY OF PORT REPUBLIC prior to the Port Day Parade And that I will take all reasonable steps to ensure that only those who have appropriately and timely filed an executed copy of LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS to participate with me in the Parade.

I certify that any vehicle(s) (if any) which will be driven by me or any other participant with whom I am participating in the Parade in the Parade has insurance which conforms to the laws of the State of New Jersey and that I and any other Participant have/has a current valid license(s).

I agree to indemnify, save, hold harmless and defend the City of Port Republic and their respective elected officials, officers, directors, employees, volunteers, partners, and/or contractors, of and from any and all loss, damages, expenses, costs, and attorney's fees arising out of or resulting from my participation in the Parade, including but not limited to any damages arising out of negligent or intentional conduct of myself, other participants accompanying me in any fashion to, during, or from the parade, and/or any other participants or other third parties.

In the event that any portion and/or provision is found to be legally insufficient for any reason, that portion and/or provision shall be severable from the remaining portions and provisions of this LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS.

This LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS shall be enforced as fully as possible to the original terms and spirit of the same in spite of any portion(s) and/or provision(s) being found to be unenforceable.

IN SIGNING THIS LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS, I acknowledge and represent that I have read the foregoing LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age, or have the written permission of a Parent or Guardian below in addition to my own signature, and am fully competent; and

I execute this LIABILITY WAIVER AND RELEASE OF THE CITY OF PORT REPUBLIC FOR PARADE PARTICIPANTS for full, adequate and complete consideration fully intending to be bound by same.

I further certify that IF SIGNING ON BEHALF OF AN ORGANIZATION, I AM AN AUTHORIZED AGENT OF SAID ORGANIZATION WITH THE POWER TO BIND AND CONTRACT ON BEHALF OF SAID ORGANIZATION.

A letter from Port Republic School Board:

The quality of education provided by the Port Republic School District has been a cornerstone of pride for our community. However, state aid cuts over the last 10 years have created a difficult financial climate for many districts. For this very reason, our school was recently identified (along with multiple other districts) as not meeting the spending threshold necessary to provide a strong education for our students despite community support. For this reason, the district became eligible for the Tax Levy Incentive Program for the 2025-2026 budget cycle.

On March 28, 2025, the Port Republic Board of Education received the following Notification of Eligibility from the New Jersey Department of Education:

Eligibility to Apply for Additional Expenditures Pursuant to Language Provision Included in Proposed FY 2026 State Budget

A language provision included in the proposed FY 2026 State Budget provides certain school districts the opportunity to apply to the Commissioner of Education (Commissioner) to increase expenditures, including an allocation of Tax Levy Incentive Aid, in order to satisfy the thoroughness and efficiency standards established pursuant to N.J.S.A. 18A:7F-46. Specifically, a school district is eligible to apply to the Commissioner if the district: 1) has an FY 2025 general fund tax levy that is less than its FY 2026 local fair share, as calculated pursuant to N.J.S.A. 18A:7F-52; and 2) is spending below adequacy as determined pursuant to N.J.S.A. 18A:7F-70. Based on the Department of Education's review of the relevant data, your district is eligible to apply for this additional authority.

The above notification informed the district that it was eligible to apply for additional tax levy as the district met the following criteria: 1) the current tax levy remains below the local fair share as determined by the State of New Jersey funding formula and 2) the district is currently spending below acceptable levels in the provision of a thorough and efficient education of students, again determined by the State of New Jersey funding formula.

Using the Tax Levy Incentive Program, the Port Republic Board of Education was able to raise the tax levy by \$299,929 while also receiving an additional \$14,996 in state aid. The Board will use the added revenue to invest in curriculum upgrades in all content area including Science/STEM initiatives, language arts, and math; provide upgrades in technology for students and staff; and focus on overdue facility repairs. This increased investment in our students and in the school will generate a quarterly tax increase of \$158 for a \$250,000 home. The Board of Education has not entered into this state program without a great deal of thought and discussion. The Board recognizes that our community may have questions about this program and will be available to respond to community concerns at the monthly Board of Education Meetings. Our next two meetings will be held on June 17, 2025 and July 15, 2025 at 5:00 PM in the school gymnasium.

As always, the Board of Education strives to provide the best education for our students while recognizing our fiscal responsibility to the taxpayers. The Board believes that this is the best path forward for our community. We greatly appreciate the on-going community support of our students, staff, and school. Thank you for all you do!


